

Special thanks for your shopping. We hope that the product you ordered is absolutely good for you, and that it will make you happy while using. We'd like to share some information regarding withdrawal.

This information is an extract of the TOS - which contains important information. Please read the relevant part of the TOS! TOS can be found as an attachment in the order confirmation email or in the origamiwebshop.hu/en website.

Our customers are entitled to withdraw from this contract without giving any reason between the date of concluding the contract and the date of receipt of the product, and within 14 days from the date of receipt of the product.

WE DO NOT RECEIVE PACKAGES BY CASH ON DELIVERY, AND SHIPMENTS BY "REMAINING IN THE POST"!

- ⇒ In case of withdrawal, repack the product (s) to be returned, the Statement of withdrawal (if filled in), all the gifts and promotions received, and send it back only to our address! Address: Origami-Bikini Kft. Hungary-6729 Szeged, Szabadkai út 89. Close the package well!
- ⇒ We will deduct their price of the missing goods (what are not returned) from the refundable amount.

<u>WITHDRAWAL REGARDING HYGIENE PRODUCTS</u> (eg SWIMWEAR / UNDERWEAR): The right of withdrawal is not valid for these products. However, we provide the opportunity to try on and to enforce the right of withdrawal only if the returned product meets ALL of the following conditions:

Product returned:

- returns in clean and impeccable condition,
- → not damaged or dirty (so it is important to try the bottoms on your own clean underwear!),
- not used at all,
- not washed, not rinsed and not used stain remover,
- ⇒ its cup after return and unpacking is not broken, (SWIMWEAR SHOULD BE RETURNED ONLY IN THE BOX either in our own box in which you received the product from us. Swimwear returned in envelopes or other soft packaging may be damaged, its cup may be wrinkled, broken, and may become unsold.)
- → the customer information label is not cut off,
- → the stitched care labels are not cut out.

If <u>any</u> of these conditions is not met, the right of withdrawal will not apply to the swimsuit. In this case, the swimsuit will returned to the buyer.

WITHDRAWAL REGARDING NON-HYGIENE PRODUCTS (eg. FITNESS CLOTHES, MERCHANDISE, etc.): If any of the above conditions are not met, we can only refund the price of the damaged products at depreciation.
